Registration Fee of \$100 should be paid upon registration. Curriculum Costs of \$300 must be paid in full before 6-1-22. Tuition can be paid in full by July 1, 2022 and a 5% discount will be given on tuition only for a max discount of \$250.00.

Midway Baptist Church members and MCA employees receive a 5% discount for a max discount of \$250.00/child. All families will receive a 5% discount for every child after the first child. A max of \$500 combined discounts allowed per child. Tuition of \$4600 can also be divided into 10 or 12 installments. The first payment is due on or before 8-1-22 . final payment due on or before 5-1-23 or 7-1-23. Ten month payments total \$460.00. Twelve month payments total \$383.33.

Any tuition not received by the 1st of each month will be charged a \$10 late fee per day, unless other arrangements have been made with the administrator. **Please include any late fees automatically with your tuition payment.**

You may pay tuition by using one of these methods: Cash, Check, Money Order, or Online. If you are paying by check or money order, please write it to Midway Christian Academy. Any returned checks will be subject to a \$25 return check fee. If a returned check is received, all future payments will have to be paid with cash or money order.

Fees required for any additional state testing: Iowa State Testing, PSAT, SAT, ACT, etc. will be paid at the time of testing. Fees required for student trips will be paid by due dates provided.

Refund Policy. When tuition is paid in full, a prorated refund will be given excluding the current month. When tuition is paid monthly, no tuition will be refunded if the student is withdrawn. **We will not refund any registration, testing fees, or curriculum costs.** Curriculum remains as MCA property. If a student’s account falls past due more than 30 days, he or she will be placed on academic probation and removed from the program until all financial matters have been cleared.

If you have any issues concerning your financial obligation to MCA, you must speak to the director to resolve this issue. **Lack of communication can be detrimental and cause unnecessary issues that may result in the removal of your family from MCA.** By signing this contract, you have agreed to all financial responsibilities.
