Thank you for considering Midway Christian Academy After School Program. We will serve our MCA student families as well as open spots to the public. Although we are located in York, SC, we are zoned for Clover School District; CSD Bethany busses will stop at our location. Along with our After School Program, we also offer a Christian K12 academy! Contact us to learn more! We are grateful for the opportunity to serve our communities!

We offer after school services to grades Kindergarten through 8th grade. We are now taking applications until all spots are full. Limited spots are available. These spots will be given to our academy students first, then remaining spots to the surrounding community. Once full, we will hold your application and place your child on a waiting list. Once an application is received, it is reviewed by the Director and School Staff, and then decided upon for acceptance. The parent/guardian is then notified as soon as possible of acceptance. The parent/guardian is responsible for transportation. Bethany Elementary parents musts make arrangements with the school. If transportation is an issue, please indicate this on the last page of the application. NOTE: This application does not guarantee admittance into the program. There will also be a small monthly fee for after school; fee pending the number of students enrolled. (Estimated \$200-250 per month depending on enrollment.)

The After School Program opened in August of 2022 and we are blessed to continue another year! We will follow the Clover School District schedule throughout the school year, including emergency and inclement weather hours of operation. The hours of operation include 2:00pm to 6:00pm. We ask that all pickups be on time out of respect to our teachers and our program, as well as required by law. Our program has to stay under 4 hours in order to operate. We also are not able to hold after school on school holidays or half days. In the event of late pickup, a \$10 fee will be charged. After 3 late pickups, the student may be expelled from the program. Thanks for your help in this matter.
